Dear YES Prep Families,

We hope this message finds you well. In case you missed it, Gov. Abbott this week issued an executive order lifting statewide COVID-19 mandates while stressing that it was *not* a call for us to "abandon safe practices that Texans have mastered over the past year." The <u>Texas Education Agency</u> subsequently affirmed in its guidance to schools that "the virus that causes COVID-19 can infect people of all ages, and school system leaders should do everything feasible to keep students, teachers, staff, and our communities safe," including "practices to prevent the virus from entering the school," such as wearing a mask over their nose and mouth, as the <u>Center for Disease Control and Prevention</u> (CDC) recommends and health officials continue to urge.

# We want to assure parents that our commitment to the health and safety of students, staff, and their families remains our top priority, and all of YES Prep's COVID-19 prevention measures, including the use of masks, follow CDC and state guidelines and <u>will remain in place</u> at all of our schools.

## SAT School Day Changed to March 24

Due to Winter Storm Uri, testing materials were delayed, and we made the decision to move the SAT test to Wednesday, March 24. If you are the parent of an 11<sup>th</sup> grader, regardless of whether they are virtual or inperson, please ensure that your child is at school and ready to take the test on March 24. We will continue to follow and prioritize health and safety guidelines at our schools to ensure your student has the best and safest testing environment. If you have any questions, please reach out to your campus Director of College Counseling.

The SAT is still heavily used in the college admissions and financial aid process as a measure of college readiness. A strong and safe SAT School Day administration on our own campuses gives our students the best chance for success on their future college applications.

## Quarter 4 Program Selection Survey – Available March 8-26

We look forward to hearing from you on your selection of online or in-person learning for next quarter. Reminder, if you wish to have your student in the same learning program for Q4, you do not need to complete the survey again. We recognize this year has been incredibly difficult for many families, and there are many factors to consider when deciding between in-person and online learning. We have a full-scale effort to welcome students for in person learning with health and safety measures to do everything we can to help keep the virus out of our schools, including:

- Required use of facial coverings over mouth and nose
- Social distancing whenever possible
- Health and temperature checks for students and staff before getting onto campus each day
- Regular hand washing while on campus
- Safety protocols on school buses
- In addition to the standard daily cleaning protocols, schools undergo intense disinfecting
- Strict adherence to CDC and state guidelines for isolating at home after a student or staffer is infected or exposed to someone infected
- Rapid testing for any staff member or any student, as approved by families, who may experience a known COVID symptom
- Anyone showing symptoms is immediately separated, and areas used by that person are cleaned and disinfected
- No non-essential visitors allowed on any campus

For students who remain online, attendance and active engagement in every class, every day will directly impact their academic success, especially as we approach STAAR testing and other critical milestones this school year. You can track your child's progress online by monitoring grades and attendance in Skyward and viewing daily assignments and activities on Teams.

Online or in person, we remain firmly committed to the rigorous education and success of your children on their path to college and beyond. Many families have reported—since their students returned in person—that they were better able to concentrate, with fewer distractions and opportunities to leave the class or miss assignments. ## School Report Cards (SRCs) and Federal Report Cards (FRCs)

The Texas Education Agency has published **2019-2020 School Report Cards** for <u>each</u> YES Prep school and **2019-2020 Federal Report Cards** for <u>each</u> YES Prep school and the district. The Texas Education Agency oversees public education in the state of Texas and requires that school districts and charter schools share information about your child's school in accordance with Texas Education Code §61.102 and Every Student Succeeds Act of 2015 (ESSA) Title I, Section 1111(h)(2). The report cards include accountability ratings, student demographic and achievement data, and financial information, to give families and the general public a broad view of the district and each school's performance.
